### The State Administration of Quality Supervision, Inspection and Quarantine, "AQSIQ on imported food Importers and Suppliers enabled filing system upgraded version of Notice" (2015 No. 98)

AQSIQ on enabling imported food Importers and Suppliers filing system upgrade notice

According to "People's Republic of China Food Safety Law" and its implementing regulations, "State Department special provisions on strengthening food and product safety supervision and management," "Imported Food Importers and Suppliers for record management regulations" and "food import records and sales records management rule" the relevant provisions of 2012 on 10 May 1 May AQSIQ official opening of Imported Food Importers and Suppliers filing system (hereinafter referred to as "filing system"). According to the newly revised "Food Safety Law" requirements, AQSIQ for the record system was upgraded, now on the relevant matters are announced as follows:

First, the opening of the new filing system

Since 2015 on 10 May 1 onwards, opening of the new filing system at <http://ire.eciq.cn>. Domestic and foreign import and export trader can log on to the system via the Internet, the information submitted for the record, for the record.

Second, for the import and export trader record

The new filing system is enabled, imported food exporters or agents overseas and domestic importers, should be in accordance "on the release <imported food Importers and Suppliers for record management regulations> and <food import records and sales records management regulations> Notice" (AQSIQ 2012 on 55 Announcement) of the relevant requirements, through a new filing system for filing, and is responsible for the authenticity of the information provided. AQSIQ according to the law or a list of agents and domestic importers exporters outside the record to be published.

Third, the completion of the import and sales records

Domestic importers imported food shall AQSIQ 2012 on 55 Announcement of the relevant requirements, fill in the import and sales records through the new filing system, including: manufacturers and exporters of food imports or foreign agents, the territory importers other information providers and shoppers, and responsible for the authenticity of information.

Fourth, the use of relevant information

Imported food importers or their agents at the time of inspection of imported food, imported food and export trader shall indicate the name and record number in the inspection list, and submit records on the import and sale of a batch of food.

Since 2015, on 10 July 1 date, AQSIQ announcement of 2012 on the 148 number "AQSIQ on the record to enable suppliers of imported food and export management system notice" abolished.
